









Human capital is obtained qualities of person which can be strengthened by investments (T. Schultz)

By past expenditures


Cumulative costs for a human capital formation



Present value of future earnings


# The number of departures from Russia (international migration)



### The number of departures and arrivals in 2019







Losses of Human capital put into operation and potential GDP losses as a result of emigration of Russian citizens in 2015 – 2019, billion rubles (in 2019 prices)

Losses of Human capital put into operation are equal to 1% of all human capital put into operation (annually)

Human capital losses are equal to 116 billion rubles (0.2% of all human capital in 2019)

Potential GDP losses are averagely equal to 530 billion rubles (0.5% of GDP)
